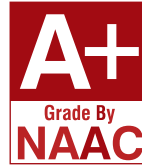

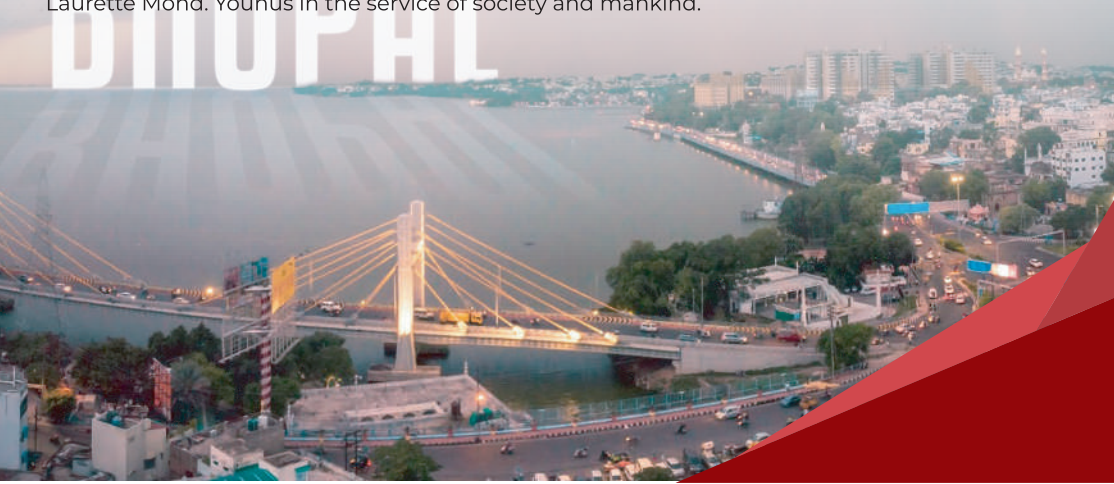
# INVITATION

- Font Size for title/heading - 14.
- Font Size for main text - 12 (justified).
- Spacing - 1.5 between line.
- Margin - 2.5

## GUIDELINES FOR FULL PAPER SUBMISSION

- First page - It should contain title along with full names of author and co-authors with designation, Institute name, contact number and email id.
- Font Style - Times New Roman for papers in English, Kruti Dev 010 for papers in Hindi.
- Font Size for title/heading - 14.
- Font Size for main text - 12 (justified).
- Spacing - 1.5 between line.
- Margin - 2.5
- Paging - Page number at the right bottom of the page.
- Figure - Title should be at the bottom of the figure.
- Tables - Table should be at the top of the table.
- References - APA format.
- The paper should be original.
- The paper should be clearly typed and should not exceed 5000 words.
- After review, the selected papers will be shortlisted for presentation.
